"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Chick Springs Township, on the southeastern side of Super Highway No. 29 and being more particularly described according to a plat of the property of Ella Mae F. Hudson prepared by Piedmont Engineering Service, July 21, 1952, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeastern side of U. S. Highway No. 29, which pin is 208.5 feet southwest of the intersection of U. S. Highway No. 29 and Richbourg Drive, at corner of lands now or formerly owned by Ella Mae F. Hudson, and running thence with the line of said land, S. 45-26 E. 200 feet to a point; thence S. 43-00 W. 92.5 feet to a point; thence N. 45-26 W. 200 feet to a point in the southeastern side of U. S. Highway No. 29; thence with said highway, N. 43-00 E. 92.5 feet to the point of beginning, including the plumbing, electrical and heating fixtures now located on said premises, or to be installed thereon, which are hereby expressly agreed to be a part of the realty. Being a portion of the property conveyed to the mortgagors by Ella Mae F. Hudson by deed dated December 4, 1952 and recorded in the R. M. C. office for Greenville County in Vol. 468, at page 81, and by a correction deed dated March 12, 1953 and recorded in the R. M. C. office for Greenville County in Vol. 474, at page 200."
