To ALL WHOM THESE PRESENTS MAY CONCERN: Joe Childers, P. T. Hood and Thomas K. Norris as Local Trustees of the North Greenville Church of God, Greenville, S. C. of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

C. DOUGLAS WILSON & CO.

, a corporation organized and existing under the laws of the State of South Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand and No/100 - - - Dollars (\$10,000.00), with interest from date at the rate of Four & One-Fourth per centum (4 1/4 %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina , or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-Two and No/100 - - - - - Dollars (\$62.00), commencing on the first day of June , 1953 , and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May , 1973 .

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All that lot of land with the buildings and improvements thereon, situate on the southeast side of Berkley Avenue, near the City of Greenville, in Greenville County, S. C., being shown as Lots Nos. 37 and 38 on plat of Franklin Park, made by W. J. Riddle, Surveyor, December 1943, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "M", at Page 89, said lots together having a frontage of 130 feet along the southeast side of Berkley Avenue and running back to a depth of 205 feet on the northeast side, to a depth of 205 feet on the southwest side and being 130 feet across the rear.

The above described property is the same conveyed to the mortgagors herein by deed of Cecil B. Cantrell and Dorothy W. Cantrell of even date and to be recorded herewith.

This mortgage and the note secured thereby are executed by the undersigned as local trustees of the North Greenville Church of God, Greenville, S. C., pursuant to the authority vested in them by resolution adopted by the congregation at a meeting duly called and held for that purpose on April 22, 1953.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
