MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Roy E. Kay and Lois S. Kay,
of Greenville County (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Lloyd W, Gilstrap

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TWENTY-FOUR HUNDRED AND SIXTY* FIVE AND 61/100

----- DOLLARS (\$ 2465.61),

with interest thereon from date at the rate of six (6) per centum per annum, said principal and interest to be repaid:

on or before July 28, 1953

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Coventry Lane, in the City of Greenville, being shown as Lot No. 60 on plat of property of Central Development Corporation, recorded in Plat Book BB at page 23, and described as follows:

"BEGINNING at a stake on the Western side of Coventry Lane, at corner of lot 61, and running thence with the line of said lot, N. 78-24 W. 116.7 feet to a stake at corner of lot 57; thence with line of said lot, N. 27-34 E. 122.57 feet to a stake at corner of lot 59; thence with the line of said lot, S. 67-24 E. 104.1 feet to a stake on Coventry Lane; thence with the Western side of Coventry Lane, S. 22-44 W. 100 feet to the beginning corner."

Being the same property conveyed to the Mortgagors by Central Development Corporation by deed recorded in Volume 458 at Page 179.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
