TO ALL WHOM THESE PRESENTS MAY CONCERN:

R. L. Bridges (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100- - - - - DOLLARS (\$ 5,000.00 ), with interest thereon from date at the rate of Five (5) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Western side of the Old Buncombe Road near the City of Greenville, being all of lot No. 18 and a portion of lot No. 19, as shown on plat of the Verner property and described as follows:

BEGINNING at a stake on the Western side of the Old Buncombe Road, 271.9 feet North from Morris Street at the corner of property now or formerly owned by R. E. Griffin, and running thence with the line of said lot N. 78-16 W. 204.6 feet to a stake; thence S. 13-45 W. 67 feet to a stake at corner of lot No. 17; thence with the line of said lot S. 77-09 E 204.8 feet to a stake on Old Buncombe Road; thence with the Western side of said Road N. 13-27 E. 71 feet to the beginning corner; Lot No. 18 being the same property conveyed to the mortgagor by Clyde L. Miller by deed recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
