Hattie W. Masters, of

organized and existing under the laws of the State of South Carolina, hereinafter

are incorporated herein by reference, in the principal sum of Forty-four Hundred -----
Dollars (\$ 4,400.00), with interest from date at the rate of Four and one-half per centum
(4½ %) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co. in Greenville, S.C.,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Twenty-seven and 85/100 ----- Dollars (\$ 27.85),
commencing on the first day of July, 19 53, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of June, 19 73.

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that certain parcel or lot of land situated on the North side
of Carolina Avenue in the City of Greer, Chick Springs Township,
Greenville County, State of South Carolina, designated as Lot No.
4 on Plat of Development No. 2, Victor-Monaghan Division of J.P.
Stevens & Co., Incorporated, Greer Plant, according to survey and
plat by Dalton & Neves, Engineers, dated April, 1947, recorded in
Plat Book "P", page 119, R.M.C. Office for Greenville County, and
being particularly designated and shown as the Property of Jacob D.
and Hattie W. Masters according to survey and plat thereof by
