BEGINNING at an iron pin in the center of Fairfield Road near the point of intersection of the driveway leading down to the residence of the grantor, and running thence just north of the aforesaid driveway, S. 73-42 E. 451 feet to an iron pin in line of the 12-acre tract belonging to the grantor, Eddie W. Gregory; thence S. 88-27 E. 334.5 feet to an iron pin; thence continuing along the same course, 14.7 feet to another iron pin; thence N. 2-50 E. 399 feet to an iron pin; thence N. 86-42 W. 464 feet to a stone; thence N. 3-34 E. 330.8 feet to a point in Fairfield Road; thence along Fairfield Road, S. 23-36 W. 515 feet to an iron pin; thence continuing along the line of Fairfield Road, S. 43-15 W. 203.5 feet to the beginning corner.

The said Association, however, retains its lien in full force and effect over the balance of the property described in said mortgage.
