Township, Greenville County, State of South Carolina. about six and one-half miles South of the City of Greenville on the South side of Branch Street, and being known as Lots Nos. 25 and 26 as shown on plat of property of Albert Q. Taylor, made by Dalton & Neves, May, 1946, and recorded in the Office of the R. M. C. for Greenville County in Plat Book P, Page 49, and having according to said plat the following metes and bounds, to-wit:
