WHEREAS I, HENRY N. FISHER, AM

well and truly indebted to

C. E. ROBINSON, AS TRUSTEE UNDER B. M. MCGEE WILL,

in the full and just sum of THREE THOUSAND FOUR HUNDRED AND NO/100 - (\$3,400.00) - Dollars, in and by my certain promissory note in writing of even date herewith, due and payable

\$34.00 on the 1st day of each and every month hereafter, commencing August 1st, 1953; payments to be applied first to interest, balance to principal; balance due five years from date, with the privilege to anticipate after one year,

with interest from date at the rate of six (6%) per centum per annum until paid; interest to be computed and paid monthly and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said Henry N. Fisher,

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said C.E. Robinson, as Trustee under B. M. McGee Will, his Successors and Assigns, forever:

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, situate, lying and being on the East side of Chandler Street, being known and designated as Lot 99 on Plat of Mountain View Land Company, recorded in Plat Book "A", Pages 396 and 397, and having according to a survey by Dalton & Neves, Engineers, the following metes and bounds, to-wit:

BEGINNING at a point on the East side of Chandler Street, which point is 200 feet North of the intersection of Chandler and Martin Streets, and running thence along the East side of Chandler Street N. 11-30 W. 50 feet to a point; thence S. 89-30 E. 148 feet to a point on the West side of a 10-foot alley; thence along the West side of said alley, S. 11-30 E. 50 feet to a point; thence N. 89-30 W. 148 feet to the point of beginning.

There is excepted from the above described lot of land a triangular strip of land conveyed by Paul H. King and Pauline G. King to Annie M. Bramlett by Deed dated May 23, 1950 and recorded in Deed Book 410, page 501.
