"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Gantt Township, on the east side of Highway No. 29, also known as the Piedmont Highway, being known and designated as a portion of Tract No. 17 of the property of E. A. Smythe, as shown on plat thereof made by Dalton & Neves, Engrs., in 1935 and recorded in the R. M. C. office for Greenville County in Plat Book D, at pages 170 and 171, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the east side of National Highway No. 29 at a point 91.25 feet north of the corner of Tract No. 18, which point is also the corner of lot now or formerly belonging to Gambrell, and running thence along the east side of said Highway No. 29, N. 2-25 W. 136.87 feet to an iron pin at the corner of a lot now or formerly belonging to Janie Watkins, which point is 136.87 feet south of the corner of Tract No. 16; thence along the line of the Watkins lot, S. 85-03 E. 513 feet to an iron pin in line of the property now or formerly belonging to E. E. Chapman, which point is 136.87 feet south of the rear corner of Tract No. 16; thence along the line of the Chapman property, S. 2-00 E. 136.87 feet to an iron pin at the rear corner of the Gambrell lot; thence along the line of the Gambrell lot, N. 85-03 W. 513.5 feet to the beginning corner." The above described lot is the same as conveyed to me by Minnie Marton by deed dated Feb. 6, 1948 and recorded in the R.M.C. effice for Greenville County in Vol. 356, page 457.
