TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, FRED M. BAKER AND JEAN R. BAKER SEND GREETING:
WHEREAS, we the said Fred M. Baker and Jean R. Baker

in and by our certain promissory note in writing, of even date with these Presents are well and truly indebted to GENERAL MORTGAGE CO., a corporation chartered under the laws of the State of South Carolina, in the full and just sum of SEVEN THOUSAND AND NO/100- (\$7,000.00) DOLLARS, to be paid at its office in Greenville, S. C., or at such other place as the holder of the note may from time to time designate in writing, with interest thereon from date hereof until maturity at the rate of five (5%) per centum per annum, said principal and interest being payable in monthly instalments as follows: Beginning on the 1st day of September, 1953, and on the 1st day of each month of each year thereafter the sum of \$74.25 to be applied on the interest and principal of said note, the unpaid balance of said principal and interest to be due and payable on the 1st day of August, 1963; the aforesaid monthly payments of \$74.25 each are to be applied first to interest at the rate of five (5%) per centum per annum on the principal sum of \$7,000.00 or so much thereof as shall, from time to time, remain unpaid and the balance of each monthly payment shall be applied on account of principal.

All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of seven (7%) per centum per annum.

And if at any time any portion of principal or interest shall be past due and unpaid, or if default be made in respect to any condition, agreement or covenant contained herein, then the whole sum of the principal of said note remaining at that time unpaid together with the accrued interest, shall become immediately due and payable, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; and if said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, before its maturity, it should be deemed by the holder thereof necessary for the protection of its interests to place, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings; then and in either of such cases the mortgagor promises to pay all costs and expenses including a reasonable attorney's fee, these to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That we, the said Fred M. Baker and Jean R. Baker

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said GENERAL MORTGAGE CO. according to the terms of the said note, and also in consideration of the further sum of THREE DOLLARS, to us

the said Fred M. Baker and Jean R. Baker in hand well and truly paid by the said GENERAL MORTGAGE CO., at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said GENERAL MORTGAGE CO.

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Northeastern side of Longview Terrace, in a subdivision known as Forest Heights, being known and designated as Lot No. 43A of said subdivision, and being as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, at page 71. According to said plat the within conveyed premises have the following metes and bounds, courses and distances, to-wit:

BEGINNING at an iron pin on the Northeastern side of Longview Terrace at the joint front corner of Lots Nos. 43A and 44, which iron pin is 872.8 feet from the intersection of Longview Terrace and East Faris Road, and running thence along the common line of said lots, N. 45-22 E. 118.7 feet to an iron pin in the center of a 10-foot strip reserved for utilities; thence along the center of said 10-foot strip reserved for utilities, S. 47-46 E. 64.2 feet to an iron pin in the center of said 10-foot strip; thence continuing along the center of said 10-foot strip and along the Southwestern side of a 10-foot alley, S. 30-20 E. 32.7 feet to an iron pin, the joint rear corner of Lots Nos. 43 and 43A; thence along the common line of said last mentioned lots, S. 48-04 W. 121.8 feet to an iron pin on the Northeastern side of Longview Terrace; thence along the Northeast side of Longview Terrace, N. 42-32 W. 79.2 feet to an iron pin, the beginning corner.
