We, John Peterson and Lynell Peterson, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or ~~lot~~ of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southeastern side of the Greenville-Hendersonville Highway, about one mile North of Travelers Rest, containing 4.36 acres, according to plat made by W. A. Hester, September 30, 1935, and having according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the Southeastern side of the Greenville-Hendersonville Highway, and running thence with said highway, S. 3 1/2 W. 38 lengths to pin; thence S. 42 1/2 E. 2.13 1/2 Ch. to pin; thence S. 53 1/2 W. 3.04 Ch. to pin; thence S. 41 1/2 E. 10.65 Ch. to iron pin on branch; thence down meanders of the branch, 4.35 Ch. to iron pin; thence N. 42 1/2 W. 14.74 Ch. to iron pin, point of beginning." Said premises being the same property conveyed to T. H. Peterson by deed recorded in Deed Book 187 at Page 389 and conveyed to the Mortgagors by deeds recorded in Volume 464 at Pages 348 and 429, respectively.
