MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Wade W. Hix,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest, S. C.,

(hereinafter referred to as Mortgagee) as evidenced by, the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand and No/100-----

-----DOLLARS (\$ 2,000.00), payable semi-annually in advance with interest thereon from date at the rate of Six (6%) per centum per annum/said principal and interest to be repaid:

\$50.00 on August 21, 1953, and like payments of \$50.00 Monthly thereafter until paid in full.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Bates Township and containing 17.52 acres, more or less, according to plat of property of Wade W. Hix recorded in Plat Book Z, Page 127, and having according to said plat the following metes and bounds to wit:

"BEGINNING at a point in highway leading to Travelers Rest at the joint corner of land heretofore conveyed by Wade Hix to Frank E. Hix and running thence according to said road S. 12-38 W. 81.7 feet to pin; thence S. 10-58 W. 225.3 feet to pin; thence S. 13-40 E. 274.2 feet to pin; thence S. 15-49 W. 226.3 feet to pin; thence S. 13-45 W. 325.9 feet to pin; thence S. 18-25 E. 321.5 feet to pin on branch; thence crossing brance S. 28-38 W. 151.9 feet to pin; thence S. 48-45 E. 214 feet to pin on road; thence S. 88-19 E. 124.8 feet; thence N. 57-52 E. 579.1 feet to pin; thence N. 66-33 E. 101.2 feet to iron pin corner of tract of Frank E. Hix ; thence N. 22-17 W. 1,310.2 feet to iron pin; thence S. 75-24 W. 213 feet to pin on road at point of beginning. "

Said premises being the Western portion of the tract of land conveyed to Wade W. Hix by Please E. Cox recorded in Book 270, Page 282.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
