on the Southern side of Dunbar Street, being known and designated as Lot No.6 on Plat of property of W.H. Irvine dated November 29, 1901, recorded in Plat Book A at Page 163 (also shown as Lot 16, Block 1, Page 85 on City Block Book, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Dunbar Street, at the joint corner of Lots Nos. 5 and 6, and running thence along the joint line of said lots, S. 18 W. 215 ft. to iron pin; thence S. 78 E. 50 ft. to an iron pin at rear corner of Lot No.7; thence with the line of Lot No.7, N. 18 E. 215 ft. to iron pin on Dunbar Street; thence with the Southern side of Dunbar Street, N. 76 W. 50 feet to the point of beginning.
