"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, , near the City of Greenville, being shown as lot No. 39 on plat of "Hollyvale" as recorded in the R.M.C. office for Greenville County, in Plat Book "Y" at page 131, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Timber Lane, at joint front corner of lots 39 and 38, and running thence along the Northeastern side of said Lane N.32-39 W. 125 feet to pin at corner of lot No. 40; thence along line of lot 40 N.59-48 E. 329.2 feet to iron pin; thence S.17-19 E. 115 feet to iron pin, corner of lot 38; thence with line of lot 38 S.57-21 W. 298.5 feet to the point of beginning.
