MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:
I, Nellie T. Cain, of Greenville, S. C., SEND GREETINGS
WHEREAS, I the said Nellie T. Cain
in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, in the
full and just sum of Three Thousand and No/100
Dollars, with interest at the rate of xixx(0,22) per centum per annum, to be repaid in installments of
Forty-five and No/100 (\$ 45.00) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.
NOW KNOW ALL MEN. That I , the said Nellie T. Cain
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, ac-
cording to the terms of said note, and also in consideration of the further sum of Three Dollars to me,
the said Nellie T. Cain in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:
"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed
within the Corporate limits of the City of Greenville, and being known

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and now within the Corporate limits of the City of Greenville, and being known and designated as Lot No. 4, of Block K, of a subdivision of the property of O.P. Mills as shown on plat thereof recorded in the R. M. C. of fice for Greenville County in Plat Book F, at page 171, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast side of West Prentiss Avenue at the corner of Lot No. 3, of Block K, which point is 250 feet southwest from the intersection of Mission Street, and running thence along the line of that lot, S. 44-33 E. 180 feet to an iron pin at the rear corner of said lot; thence S. 45-27 W. 62 feet to an iron pin at the rear corner of Lot No. 5, of Block K; thence along the line of that lot, N. 44-33 W. 180 feet to an iron pin at the corner of said lot on the southeast side of West Prentiss avenue; thence along the line of said avenue, N. 54-27 E. 62 feet to the beginning corner."

The above described lot is the same as conveyed to me by Daniel R. Can by deed recorded in the R. M. C. office for Greenville County in Vol. 176 at page 76.
