with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid: \$30.00 on November 1, 1953 and a like payment of \$30.00 on the 1st day of each month thereafter until paid in full, said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of Six (6%) per cent, per annum to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Eastern side of Drayton Drive, being known and designated as lot No. 134, on plat of University Heights, recorded in Plat Book BB at Page 21, and described as follows:

"BEGINNING at an iron pin on the Eastern side of Drayton Drive, at the corner of lot No. 133, and running thence with the line of said lot, N. 59-34 E. 199.2 feet to an iron pin; thence S. 29-16 E. 100 feet to an iron pin at the rear corner of lot No. 135; thence with the line of said lot, S. 59-34 W. 196.8 feet to an iron pin in the mastern side of Drayton Drive; thence with said Drive, N. 30-26 W. 100 feet to the point of beginning."
