TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. R. CORDELL - - - - - (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of - - - FIVE THOUSAND & NO/100 - - - - - DOLLARS (\$ 5,000.00 - - -), with interest thereon from date at the rate of Six (6%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Eastern side of Reid's School Road, near the City of Greenville, being the major portion of Lot 14, as shown on plat of the J. E. Flynn Estate made by H. S. Brockman in November 1940, recorded in Plat Book "O", at Page 75, and described as follows:

BEGINNING at a stake on the Eastern side of Reids School Road at corner of the right-of-way of P. & N. Railroad, and also at corner of U. S. Highway No. 29, and running thence with right-of-way of said railroad N. 48-30 E. 344.5 feet to a stake; thence N. 1-26 W. 67.9 feet to a stake at corner of property of W. B. and Isabelle Harter, and running thence with the line of said property approximately S. 69-45 W. 290 feet, more or less, to a stake on the Reids School Road; thence with the Eastern side of said road S. 4-15 E. 185 feet to the beginning corner, being a portion of the property conveyed to Marvin Rollins by deed recorded in Deed Book 269, at Page 37, and by him devised to the Grantor by his Will as Apartment 615, File 14, in the Office of the Probate Judge for Greenville County.

Being the same property conveyed to Mortgagor by Eva Noble Rollins by deed dated October 15, 1953, to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
