WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Austin

Township, and being designated as Lot No. 5 in a subdivision known as Hunters Acres, according to a survey and plat made by W. J. Riddle in May, 1952, and recorded in the R. M. C. office for Greenville County in Plat Book "BB", Page 51, and being more fully described as follows: Beginning at the corner of Florence Drive and Maple Street at an iron pin and running N. 27-12 W. along Maple Street for 80 feet to an iron pin at joing corner of Lots No. 5 and No. 4; thence running along the joint line of said lots S. 60-08 W. for 201.8 feet to an iron pin on corner of Lots No. 4 and 5 and at a point on line of Lot No. 54; thence S. 27-12 E. along joint lines of Lots No. 5 and 54 to an iron pin on Florence Drive; thence N. 58-41 E. for 200 feet to the beginning point."

This being the identical land conveyed to the mortgagor by Simpsonville Lumber & Supply Company, Inc. by deed dated November 5, 1953, and recorded simultaneously with this mortgage in the R. M. C. office for Greenville County.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
