To All Whom These Presents May Concern:

We, Claude Austin and Carolyn Austin, of Greenville, S.C., SEND GREETING:

Whereas, we, the said Claude Austin and Carolyn Austin,  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to John C. Henry,  
in the full and just sum of THREE HUNDRED and no/100 (\$300.00) DOLLARS,  
to be paid as follows: One (1) year after date,

with interest thereon from date  
at the rate of 7 per centum per annum, to be computed and paid semi-annually  
until paid in full; all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to  
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That we, the said Claude Austin and Carolyn Austin,

in consideration of the said debt and  
sum of money aforesaid, and for the better securing the payment thereof to the said John C. Henry,  
according to the terms of the said note, and also in  
consideration of the further sum of Three Dollars, to us, the said Claude Austin and Carolyn  
Austin, in hand well and truly paid by the said John C. Henry,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,  
sold and released, and by these Presents do grant, bargain, sell and release unto the said John C. Henry,  
his heirs and assigns,

All that piece, parcel or lot of land in Greenville Township,  
Greenville County, State of South Carolina, being known and designated  
as Lot Number Twenty Four (No. 24) of the L.A. Mills subdivision, in the  
City of Greenville, as represented by a plat of said subdivision record-  
ed in Plat Book "H" at page 117-118 in the R.M.C. office for Greenville  
County, and, according to said plat, having the following metes and bounds:

BEGINNING at a point, southeastern corner of Gower Street and  
Columbus Avenue, and running thence along the south side of Gower Street,  
S. 59-07 E. 48.6 feet to corner of Lots Nos. 23 and 24; thence S. 42-01  
W. 111.6 feet to pin in line of Lot No. 25; thence N. 45-47 W. 51.5 feet  
to point on southeastern side of Columbus Avenue; thence along the south-  
eastern side of Columbus Avenue, N. 44-13 E. 100 feet to the beginning cor-  
ner; this being the same property conveyed to Claude Austin, one of the  
mortgagors herein, by Inez Larson by deed dated Jan. 3, 1938, recorded in  
Vol. 201 at page 217 in said R.M.C. office, and the same conveyed to said  
Inez Larson by B. G. Abner by deed dated May 19, 1937, recorded in Vol. 196  
at page 50 in said R. M. C. office.
