Whereas, I, the said Fred Neal, Jr.

in and by my certain promissory note in writing, of even date with these

Presents, am well and truly indebted to William I. Bouton, Attorney

in the full and just sum of Four Hundred and No/100ths (\$400.00)- - - - -

Dollars, to be paid in monthly installments of \$75.00, the first installment to be paid on the first day of February, 1954, and a like installment on the first day of each month thereafter until paid in full

, with interest thereon from date

at the rate of 6% per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

Bouton, Attorney, all that piece, parcel or lot of land situate, lying and being in Greenville Township, County and State aforesaid, on the South side of Dukeland Drive shown as Lot No. 41 and portions of Lots Nos. 40 and 42 on a plat of Dukeland Park recorded in the R. M. C. Office for the County and State aforesaid in Plat Book J at page 221, and being more particularly described as follows:

BEGINNING at a stake on the South side of Dukeland Drive 664.8 feet East of McMakin Drive, and running thence S. 38-11 E. 251.2 feet to a stake; thence N. 33-13 E. 42.5 feet to a stake at the corner of Lot No. 42; thence with the line of said lot N. 33-07 W. 63.6 feet to a stake; thence N. 25-26 E. 50.8 feet to a stake in the line of Lot No. 43; thence with the line of said lot N. 29-41 W. 106.8 feet to a stake on Dukeland Drive; thence with the South side of Dukeland Drive S. 66-01 W. 100 feet to a stake; thence along Dukeland Drive S. 54-18 W. 10 feet to the beginning corner.
