Whereas, we, the said R. W. Manley and Eva Mae Manley

\$52.74 on the 24th day of January, 1954 and a like amount on the 24th day of each and every month thereafter until the entire principal sum is paid in full, said installments to be applied first in payment of interest and then to principal, balance due 10 years from date, with the privilege to the mortgagors to anticipate any or all of said indebtedness on any interest paying date

, with interest thereon from date

at the rate of six (6%) percentum per annum, to be computed and paid

monthly

until paid in full; all interest not paid when due to bear

All that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, and being known and designated as Lot Number 32 of the property of Central Realty Corporation according to a plat of record in the R. M. C. Office for Greenville County in Plat Book S at page 110, and having the following metes and bounds, to-wit:

Beginning at a point on the eastern side of Hampton Street (now Nancy Drive) at the joint front corner of Lots 31 and 32 and running thence N. 65-00 E. 205 feet to a point at the joint rear corner of Lots 31 and 32; thence N. 25-00 W. 129.6 feet to a point on the Southeastern side of Sumter Street; thence with the southeastern side of Sumter Street S. 46-06 W. 216.2 feet to a point at the Southeastern intersection of Hampton Street with Sumter Street; thence with the Eastern side of Hampton Street S. 25-00 E. 60 feet to the point of beginning.
