Whereas, I, the said Nancy Willis

, to be paid as follows: Fifteen & no/100 Dollars (\$15.00)  
to be paid between the first and fifth day of each and every month succeeding  
the date hereof until the interest and principal is paid in full.

, with interest thereon from date  
at the rate of 6 per centum per annum, to be computed and paid quarterly

until paid in full: all interest not paid when due to bear  
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,  
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the  
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof  
necessary for the protection of his interests to place and the holder should place the said note or this mortgage  
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises  
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to

All that certain piece, parcel or lot of land situate, lying and being in  
the State and County aforesaid, Chick Springs Township, about one mile southwest  
from Greer, S. C., lying on the east side of the new road that leads from  
Pleasant Grove Baptist Church off State Highway No. 14, to and by Matt's fish-  
ing lake, being bounded on the northern side by lot recently conveyed to John  
Oliver, on the easter side by lands of I. M. Wood Estate, on the southern side  
by a lot being conveyed by J. A. Wood to Furman Rollins and Lona Rollins on  
Aug. 2, 1952, and on the western side by the said road and other lands of J. A.  
Wood, being a part of tract No. 2 as shown on Plat of property of J. G. Greer,  
L. B. Vaughn, I. M. Wood and J. A. Wood, said plat prepared by W. A. Christopher,
