NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the southeast side of Hammett's Bridge Road about  $2\frac{1}{4}$  miles southwest from Greer, containing 3.85 acres, more or less, and being a portion of Lot No. 15 of the John G. Greer property, and having the following courses and distances, to wit:

Beginning at the joint corner of Lots Nos. 14 and 15 on said road, and running thence with the road, S. 59.10 W. 243.5 feet to an iron pin; thence S. 31.00 E. 658 feet, more or less, to pin in Smith or Ross line; thence with that line, N. 67.45 E. 246.6 feet to joint corner of Lots Nos. 15 and 16; thence with the line of Lot No. 16, N. 31.00 W. 707 feet to the beginning corner.
