Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co., - - - -

organized and existing under the laws of South Carolina, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of SEVEN THOUSAND, THREE HUNDRED FIFTY & 00/100
Dollars (\$ 7,350.00), with interest from date at the rate of four and one-half per centum
(4½ %) per annum until paid, said principal and interest being payable at the office of -----
C. Douglas Wilson & Co., in Greenville, South Carolina
or at such other place as the holder of the note may designate in writing, in monthly installments of
Forty Six & 53/100 ----- Dollars (\$ 46.53),
commencing on the first day of April, 1954, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of March, 1974.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and im-
provements thereon, situate, lying and being in the City of Greenville,
County of Greenville, State of South Carolina, being known and desig-
nated as Lot No. 1, Plat of Parkview, as per plat thereof recorded
in the R.M.C. Office for Greenville County, South Carolina, in Plat
Book M, page 49; said lot having a frontage of 65 feet on the South-
easterly side of Alaska Avenue (formerly Morningside Drive), a depth
of 150 feet on the Southwest, a depth of 151.7 feet on the Northeast
and 43.1 feet across the rear.

ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
