NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, being known and designated as the Southern portion of Lot 100, as shown on Map No. 2 of Camilla Parks, recorded in Plat Book "M", at Page 86, and being more particularly described according to a recent survey prepared by C. C. Jones, as follows:

"BEGINNING at an iron pin in the East side of York Drive (formerly Blythewood Drive), joint front corner of Lots 99 and 100, and running thence along the Eastern side of York Drive, N. 19-00 W. 60 feet to an iron pin; thence on the new line through Lot 100, N. 72-35 E. 108.9 feet to an iron pin; thence S. 9-28 E. 80.6 feet to an iron pin, rear corner of Lot 99; thence with line of said lot, S. 84-15 S. 98.5 feet, to the point of beginning."
