TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Clarence C. Lipscomb, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Four Thousand and No/100

DOLLARS (\$4,000.00), with interest thereon from date at the rate of five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Southeast corner of the intersection of Lavinia Avenue and Henrietta Street (formerly Franklin Avenue), shown as Lot 34 on the plat of the Rowley property, and recorded in Plat Book "C", at Page 5, and having according to plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the Southeast corner of the intersection of Lavinia Avenue and Henrietta Street, and running thence with the Southern side of Henrietta Street, N. 58-30 E. 157.5 feet to a stake at corner of Henrietta Street and a ten foot alley; thence along the Western side of said alley, S. 21-16 E. 100 feet to corner of Lots 33 and 34; thence with line of Lot 33, S. 73-08 W. 155.4 feet to an iron pin on the Eastern side of Lavinia Avenue; thence with the Eastern side of Lavinia Avenue, N. 21-22 W. 60 feet, to the point of beginning."

Said premises being the same conveyed to the mortgagor by deed recorded in Volume 279, at Page 420.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
