MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Roy Cunningham & Mamie B. Cunningham

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Three Thousand and No/100

DOLLARS (\$ 3,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the Eastern side of Tubs Mountain Road Extension, near the town of Travelers Rest, being the Western portion of the tract designated "Roy and Mamie Cunningham" on plat of property of Ray McAlister, recorded in Plat Book "S", at Page 153, and described as follows:

"BEGINNING at a stake in Tubs Mountain Road, 290 feet North from Highway No. 253 and running thence S. 87-45 E. 336.4 feet to a stake at corner of property of Grover C. Moody; thence with line of said lot, N. 1-41 E. 198 feet to a stake; thence N. 87-45 W. 340 feet to a point in Tubs Mountain Road; thence with said road, S. 00-39 W. 198 feet to the beginning corner." Subject to a 20 foot driveway across the southern line for use of property of Grover C. Moody.

Being the remainder of the property conveyed to the mortgagors by Ray McAlister after the conveyance of the portion to Grover C. Moody by deed recorded in Volume 383 at Page 23.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
