To All Whom These Presents May Concern:

I, Corene H. West - - - - - SEND GREETING:

WHEREAS, I the said Corene H. West

in and by my certain promissory note in writing of even date with these Presents, am well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of Twenty-two Hundred Fifty & no/100 - - - (\$ 2250.00) Dollars, with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of

Thirty-six & 50/100 - - - (\$ 36.50) dollars due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That I the said Corene H. West, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING & LOAN ASSOCIATION, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to me the said mortgagor— in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, lying about two miles North of Greer, S. C., and on the South side of the Ansel School Road and on the West side of a dirt road that leads off of the Ansel School Road, and known as lots 11, 12 and 13 on a plat of property made for J. C. Bruce, by H. S. Brockman, Surveyor, September 11, 1953, and having the following metes and bounds according to said plat:-

BEGINNING at a point on said dirt road at the corner of lot 10 and runs thence N 61-23 W. 241.5 feet along the line of lot 10 to a point on the line of lot 14; thence S. 34-45 W. 280 feet along the east line of lot 14 to an old iron pin in the center of said dirt road; thence S. 54-15 E. 240 feet along the said dirt road to a stake; thence N. 34-45 E. 310 feet to the beginning corner, and containing one and one-half acres more or less.

This is the same property conveyed to me by J. C. Bruce by deed dated November 9, 1953, to be recorded in R. M. C. Office for Greenville County.
