MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Clear View Baptist Church

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Bank of Travelers Rest,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and No/100

DOLLARS (\$ 5000.00),

with interest thereon from date at the rate of Five per centum per annum, said principal and interest to be repaid: \$250.00 on May 16, 1954, and a like payment of \$250.00 quarterly thereafter until paid in full, with interest thereon from date at the rate of Five (5%) per cent, per annum, to be computed and paid quarterly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, lying on the South side of State Highway # 23-22, known as the Little Texas Road, and bounded on all sides by other lands of Don B. Howell, containing 1 and 17/100 Acres, more or less, including the highway right-of-way, and having the following metes and bounds:

"BEGINNING at an iron stake in North Shoulder of above Highway 12 feet from center line and 100 feet, N. 74-00 W. from corner at road fork and running thence N. 74-00 W. 200 feet to angle iron on North shoulder of highway; thence S. 16-00 W. 217.8 feet to iron pipe; thence S. 74-00 E. 200 feet to iron pin; thence N. 16 E. 217.8 feet to iron pin on R.O.W. and continuing N. 16-00 E. 37 feet to the beginning corner."

Being the same property conveyed to the mortgagor by Don B. Howell by deed to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
