I, William H. Keith, II, hereinafter spoken of as the Mortgagor send greeting.

is justly indebted to C. Douglas Wilson & Co., a corporation organized and existing under the laws of the State of South Carolina, hereinafter spoken of as the Mortgagee, in the sum of

FIFTEEN THOUSAND AND NO/100 Dollars

(\$ 15,000.00), lawful money of the United States which shall be legal tender in payment of all debts and dues, public and private, at the time of payment, secured to be paid by that one certain note or obligation, bearing even date herewith, conditioned for payment at the principal office of the said C. Douglas Wilson & Co., in the City of Greenville, S. C., or at such other place either within or without the State of South Carolina, as the owner of this obligation may from time to time designate, of the sum of

FIFTEEN THOUSAND AND NO/100 Dollars (\$ 15,000.00)

with interest thereon from the date hereof at the rate of 5 per centum per annum, said interest to be paid on the 1st day of April 19 54 and thereafter said interest and principal sum to be paid in installments as follows: Beginning on the 1st day of May 19 54, and on the 1st day of each month thereafter the sum of \$ 99.00 to be applied on the interest and principal of said note, said payments to continue up to and including the 1st day of March 19 74, and the balance of said principal sum to be due and payable on the 1st day of April 19 74 the aforesaid monthly payments of \$ 99.00 each are to be applied first to interest at the rate

of 5 per centum per annum on the principal sum of \$ 15,000.00 or so much thereof as shall from time to time remain unpaid and the balance of each monthly payment shall be applied on account of principal. Said principal and interest to be paid at the par of exchange and net to the obligee, it being thereby expressly agreed that the whole of the said principal sum shall become due after default in the payment of interest, taxes, assessments, water rate or insurance, as hereinafter provided.

BEGINNING at an iron pin on the Southwesterly side of East Faris Road, joint front corner Lots 67 and 68, said iron pin being 1366 feet around a curve and in a Southeasterly direction from the intersection of East Faris Road and Longview Terrace, and running thence S. 53-45 W. 202.7 feet to an iron pin; thence S. 26-58 E. 100 feet to an iron pin; thence N. 54-0 E. 210.5 feet to an iron pin on the Southwesterly side of East Faris Road; thence along the Southwesterly side of East Faris Road N. 31-00 W. 100 feet to an iron pin, the point of beginning.
