All that parcel or lot of land/in Oaklawn Township, Greenville County, State of South Carolina, containing Two and sixty-five one-hundredths (2.65) acres, more or less, lying and being situated in Eastview School District, and being designated as Lot number One (1) of the H. F. Beam subdivision, said plat made in September, 1947, by W. J. Riddle, and having the following metes and bounds to wit:

BEGINNING at corner of J. W. King's line in center of public road, thence along J. W. King, Jr. line N. 18-0 E. 241 feet to joint corner of King and Beam lines; thence along the line of H. F.
