WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-Five Hundred and No/100- - - - - DOLLARS (\$4500.00

), with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Duncan Road, in Paris Mountain Township, containing 0.39 of an acre, and having according to plat made by J. C. Hill, dated March 30, 1954, the following metes and bounds, to-wit:

"BEGINNING at a nail and cap in the center of Duncan Road, at the joint corner of property of B. F. Edwards and Mrs. Rhett Martin, and running thence with line of the Martin Property, N. 39 W. 202.1 feet to iron pin; thence with the line of property of B. F. Edwards, N. 44-15 E. 71.5 feet to iron pin; thence continuing with line of Edwards Property, S. 45-45 E. 200 feet to nail and cap in center of Duncan Road; thence with said Road, S. 44-15 W. 100 feet to point of beginning. Being the same premises conveyed to the mortgagors by deed recorded in Volume 497 at Page 250."
