To All Whom These Presents May Concern:

SEND GREETING:

Whereas, I, the said GASSAWAY GRIFFIN
in and by my certain promissory note in writing, of even date with these
Presents, am well and truly indebted to OSCAR HODGES AND SARAH HODGES
in the full and just sum of SIX HUNDRED & NO/100 (\$600.00) DOLLARS
, to be paid \$5.00 a month with semi-annual interest in addition,
the entire debt, however, to become due three (3) years from date

, with interest thereon from date
at the rate of 6 per centum per annum, to be computed and paid semi-annually
until paid in full: all interest not paid when due to bear
interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage
in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises
to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to
the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said
OSCAR HODGES AND SARAH HODGES, their heirs and assigns;

All that lot of land in Greenville Township, Greenville County, State of South
Carolina known and designated as Lot No. 5 according to a plat recorded in the
Greenville County R. M. C. Office in Plat Book "4", page 138. This lot is located
on the south side of Arnold Street, has a frontage of 50 feet on Arnold Street
and runs back southeasterly 125 feet to the line of lot No. 6 on said plat.

This is the same property conveyed to me by H. A. Croft by deed dated October 20,
1930 and recorded in Vol. 363, page 175 in said R. M. C. Office.

This mortgage is junior in rank to the mortgage given by me to Oscar Hodges and
Sarah Hodges in the original sum of \$1,167.67 on January 22, 1934 and recorded in
Greenville County R. M. C. Office in Vol. 584, page 303.
