BEGINNING at an iron pin on the Northeastern side of Lullwater  
Road, which iron pin is the joint front corner of Lots Nos. 39  
and 38 and is situate S. 37-13 E. 78.1 feet from the intersection  
of Lullwater Road and Poppy Way; running thence along the joint  
line of said last mentioned Lots, N. 55-12 E. 207.8 feet to an
