## **MORTGAGE**

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I (WWS), \_\_\_\_\_\_\_Alice A. Pressley hereinafter called the Mortgagor, SEND GREETINGS:

WHEREAS, the Mortgagor in and by his certain promissory note in writing, of even date with these Presents is well and truly indebted to GENERAL MORTGAGE COMPANY, a corporation chartered under the laws of the State of South Carolina, hereinafter called the Mortgagee, in the principal sum of

Twenty One Hundred and no/100 ----

(\$ 2100.00 \_\_\_\_) DOLLARS, to be paid at its office in Greenville, S. C., or at such other place as the holder of the note may from time to time designate in writing, with interest thereon from the date thereof until maturity instalments as follows:

Beginning on the 1st day of June, 1954 and on the 1st day of each MONTH of each year thereafter the sum of \$27.60 \_\_\_\_\_, to be applied on the interest and principal of said note, the unpaid balance of said principal and interest to be due and payable on the 1st day of \_\_\_\_\_\_\_, May \_\_\_\_\_\_\_\_, 19.62, the aforesaid MONTHLY payments each are to be applied first to interest at the rate of SIX (6%) per centum per annum on the principal sum of said note or so much thereof as shall, from time to time, remain unpaid and the balance of each MONTHLY payment shall be applied on account of principal.

The privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments that are next due on the principal thereof, on the first day of any month prior to maturity; provided that written notice of an intention to exercise such privilege is given at least 30 days and not more than 60 days prior to prepayment. Such prepayment shall operate to accelerate the ultimate maturity date pro tanto.

All instalments of principal and all interest are payable in lawful money of the United States of America; and in the event default is made in the payment of any instalment or instalments, or any part thereof, as therein provided, the same shall bear simple interest from the date of such default until paid at the rate of SIX (6%) per centum per annum.
