SEND GREETINGS:

Whereas, I, the said T. M. Massey in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, in the full and just sum of Fifty-One Hundred and no/100 - - - - - Dollars, (\$5100.00 ) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum (6%) per annum, to be repaid in installments of Fifty-One and no/100 - - - - - \$51.00 Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

All that piece, parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, containing 57.50 acres, more or less, designated as Tract No. 2 on plat made by W. J. Riddle, Surveyor, dated March, 1947 and recorded in Plat Book Q, at page 186, RMC Office for Greenville County, bounded on the Northeast by Tract No. 1 of said plat; on the Southeast by lands of W. L. Farrow, one the Northwest by lands now or formerly of W. C. Davis. Said tract of land being the same conveyed to me by P. L. Farrow on the 9th day of April, 1947 and recorded in the RMC Office for Greenville County in Deed Book 312, at page 5.
