TO ALL WHOM THESE PRESENTS MAY CONCERN: T. S. MEADERS

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto The First National Bank of Greenville, S.C. as Trustee (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Hundred and No/100 - - - -

DOLLARS (\$1,500.00),

with interest thereon from date at the rate of Six (6%) per centum per annum, said principal and interest to be repaid: Interest only is payable from date to June 1, 1955 at rate of Six (6%) per cent, semi-annually and on July 1, 1955 a payment of \$66.49 and a like payment of \$66.49 monthly thereafter until paid in full; said payments to be first applied to interest and the balance to principal with interest thereon from date at the rate of Six (6%) per cent, per annum, to be computed and paid semi-annually until June 1, 1955 and thereafter monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the North side of Blue Ridge Drive, formerly Arlington Avenue, and being shown as lot No. 8 on Plat of B. E. Geer Property, recorded in Plat Book "G" at Page 237 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a stake on the North side of Blue Ridge Drive, joint front corner of Lots Nos. 7 and 8, and running thence along the North side of Blue Ridge Drive, N. 83-55 E. 60 feet to joint front corner of Lots Nos. 8 and 9; thence N. 5-50 W. 150 feet to stake; thence S. 83-55 W. 60 feet to stake; thence S. 5-50 E. 150 feet to the beginning corner.

Said lot being also shown as Lot No. 24, Block 7, Page 167, of the County Block Book, and being the same conveyed to the Mortgagor by deed recorded in Book of Deeds 154 at Page 335."

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
