TO ALL WHOM THESE PRESENTS MAY CONCERN:

Carl L. Gullick, Jr. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Ten Thousand and No/100 -----
DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Waccamaw Avenue in the City of Greenville, being shown as Lot 67 on plat of the property of C. B. Martin, recorded in Plat Book F at pages 102 and 103, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Waccamaw Avenue at corner of Lot 66 and running thence with line of Lot 66 S. 41-10 E. 347.6 feet to iron pin in line of Jenkinson property; thence with the line of said property N. 55-43 E. 75.55 feet to iron pin at rear corner of Lot 68; thence with line of Lot 68 N. 41-10 W. 356.7 feet to iron pin on Waccamaw Avenue; thence with the eastern side of Waccamaw Avenue S. 48-50 W. 75 feet to the point of beginning.

Said premises being the same conveyed to the mortgagor by deed recorded in in Deed Book 432 at Page 366.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
