NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs, Township, in the City of Green, lying on the South side of Carolina Avenue, known and designated as Lot No. 22 on plat of Development No. 2 made for J.P. Stevens & Co., Inc., recorded in the R.M.C. Office for Greenville County in Plat Book P, at page 119, and having the following courses and distances: BEGINNING on cement marker on South side of Carolina Avenue, joint corner with lot No. 21, and runs thence S. 35.21 W. 170 feet to cement marker on alley; thence with alley S. 54.39 E. 105 feet to cement marker, corner of Lot No. 23; thence No. 35.21 E. 170 feet to cement marker on Carolina Avenue; thence therewith No. 54.39 W. 105 feet to the beginning corner, and being that lot of land purchased by the mortgagor from Ralph W. Brown, as appears by reference to record of deed in the R.M.C. Office for Greenville County.
