WHEREAS, the Mortgagor is well and truly indebted unto

LIBERTY LIFE INSURANCE COMPANY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand Four Hundred Dollars (\$ 10,400.00), with interest from date at the rate of Four & one-half per centum (4½%) per annum until paid, said principal and interest being payable at the office of Liberty Life Insurance Company in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-five and 83/100 -----Dollars (\$ 65.83), commencing on the first day of August, 19 54, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of July, 19 74.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate on the Southeast side of West Prentiss Avenue, in the City of Greenville, Greenville County, South Carolina, shown as Lot 3 of Block "K" on Plat of Property of O. P. Mills, made by R. E. Dalton, April, 1924, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "F", at page 171, and having according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southeast side of West Prentiss Avenue at joint front corner of Lots 2 and 3 of Block "K", and running thence with the line of Lot 2, S. 44-33 E., 180 feet to an iron pin; thence S. 45-27 W., 62 feet to an iron pin; thence with the line of Lot 4, N. 44-33 W., 180 feet to an iron pin on the Southeast side of West Prentiss Avenue; thence with the Southeast side of West Prentiss Avenue, N. 45-27 E., 62 feet to the beginning corner.
