and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and
released, and by these presents do grant, bargain, sell and release unto the said

First National Bank of Greenville, S. C., as Trustee under Agreement
with Huntington & Guerry, Inc., dated August 6, 1949, that tract or lot of land in
its successors and assigns:
Greenville Township, Greenville County, State of South Carolina,
in School District No. 7-1 and on the West side of West Circle Avenue,
being designated as Lot No. 68 as shown on a plat of East Lake recorded
in Plat Book "G" at page 229 and having the following metes and bounds,
to-wit:

BEGINNING at a point on the West side of West
Circle Avenue a distance of 479.3 feet South of the Southwest inter-
section of West Circle Avenue and the Spartanburg Road and being the
joint Northern corner of Lots Nos. 67 and 68 and thence running along
West Circle Avenue, S. 37-20 E. 60 feet to an iron pin at the corner
of Lot No. 69; thence along the joint line, S. 52-40 W. 182.7 feet
to the joint rear corner of said lots; thence along the rear line,
N. 37-20 W. 60 feet to an iron pin at the rear corner of Lot No. 67;
