I, Macie B. Duncan

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Sixty-Five Hundred and No/100- - - -**

**DOLLARS (\$6500.00**), with interest thereon from date at the rate of **Five (5%)** per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as lot # 10, as shown on a plat of Davis Property, Eastover, recorded in Plat Book AA at Page 123, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the Southwest side of Beechwood Avenue, at the joint front corner of lots 10 and 11, which pin is 67.3 feet Southeast of the intersection of Beechwood Avenue and Haviland Avenue and running thence with Beechwood Avenue, S. 29-23 E. 67.3 feet to an iron pin, corner of lot 9; thence with line of said lot, S. 55-47 W. 132.85 feet to an iron pin in line of lot now or formerly owned by B. C. Boland; thence with the line of said lot, N. 28-00 W. 70 feet to iron pin, rear corner of lot 11; thence with line of said lot, N. 56-53 E. 131 feet to the point of beginning."

Being a portion of the premises conveyed to the mortgagor by Lois T. Davis by deed recorded in Book of Deeds 460 at Page 364.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
