To All Whom These Presents May Concern:

Whereas, I DONALD BALTZ SEND GREETING:  
, the said Donald Baltz  
hereinafter called the mortgagor(s)  
in and by my certain promissory note in writing, of even date with these presents, am well and truly  
indebted to L. A. MOSELEY & JOHN T. DOUGLAS  
hereinafter called the mortgagee(s), in the full and just sum of One Thousand One Hundred Sixty-two  
and 50/100 - - - - - DOLLARS (\$ 1162.50 ), to be paid

six (6) months from date,

, with interest thereon from date  
at the rate of Five (5%) percentum per annum, to be computed and paid

semi-annually until paid in full; all interest not paid when due to bear  
interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole  
amount evidenced by said note to become immediately due, at the option of the holder hereof. who may sue thereon and foreclose  
this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if, be-  
fore its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder  
should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases  
the mortgagor(s) promise to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be  
added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That I , the said mortgagor(s), in consideration of the said debt and sum of money aforesaid,  
and for the better securing the payment thereof to the said mortgagee(s) according to the terms of the said note, and also in con-  
sideration of the further sum of Three Dollars, to me , the said mortgagor(s), in hand well and truly paid by the said mort-  
gagee(s) at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and  
released and by these Presents do grant, bargain, sell and release unto the said L. A. Moseley & John T.  
Douglas, their heirs and assigns, forever:

ALL that lot of land on the Southeast side of Nottingham Road near the  
City of Greenville, in Greenville County, South Carolina, being shown  
as Lot 195 on plat of Sherwood Forest, made by Dalton & Neves, Engineers,  
August, 1951, revised through November, 1952, recorded in the R.M.C.  
Office for Greenville County, S. C., in Plat Book "GG", at pages 2 and  
3; said lot fronting 95 feet along the Southeast side of Nottingham  
Road, and running back to a depth of 171.8 feet on the Northeast side,  
to a depth of 176 feet on the Southwest side and being 95.1 feet a cross  
the rear.
