WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Hundred and No/100- - - -

DOLLARS (\$ 2500.00 ), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, at the Southwest corner of the intersection of Second Avenue and D Street, being known and designated as lot #53, Section 1, on plat of property of F. W. Poe Manufacturing Company, recorded in Plat Book Y at Pages 26 and 27, and described as follows:

"BEGINNING at an iron pin on the Southwest side of Second Ave ue, at the joint front corner of lots 53 and 54, and running thence with Second Avenue, S. 41-14 E. 76.8 feet to iron pin, at intersection of Second Avenue and D Street; thence with the Western side of D Street, S. 48-52 W. 70 feet to pin at corner of lot 52; thence with line of lot 52, N. 41-14 W. 77.5 feet to pin in line of lot 54; thence with line of lot 54, N. 49-26 E. 70 feet to the point of beginning. Said lot also being shown as lot #9, Block 12, Page 150, of the County Block Book, and being the same premises conveyed to the mortgagor by deed recorded in Volume 420 at Page 194."
