Map of Air Base Farms, made by Dalton & Neves, and dated November 1955,

BEGINNING at a point on the Eastern edge of Standing
Springs Road, which point is a joint corner with lot conveyed to Mrs.
Ruby McAbee, this corner being 210 feet from the Southeastern intersection
of 2nd Street and Standing Springs Road; running thence along the Eastern
edge of Standing Springs Road, S. 55-14 E. 210 feet to corner; thence N.
30-14 E. 330.3 feet to a point in Zimmerman's line; thence with Zimmerman's
