WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Fairview Township, being about 2 miles west of the town of Fountain Inn and being more fully described as follows:

BEGINNING at an iron pin in the center of a county road leading from the Laurens Road at Hamp Bryson's place to Greenpond Church, the said pin being 1000 feet north from the center of the crossing of the said road and C. & W. C. Rail Road crossing and running thence along the center of the country road N. 21 - 15 W. 209 feet to an iron pin, thence S. 68 - 45 W. 209 feet to an iron pin, thence S. 21 - 15 E. 209 feet to an iron pin, thence N. 68 - 45 E. 209 feet to the beginning point and containing one acre.
