TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Jerry Kelley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Henry Harding

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of ~~Thirty-Four~~ Hundred Fifty

and 14/100- - - - - DOLLARS (\$341.00)

with interest thereon from date at the rate of 5 per centum per annum, said principal and interest to be repaid: \$20.00 on September 12, 1954, and a like payment of \$20.00 on the 12th day of each month thereafter until paid in full, with full prepayment privilege at any time, said payments to be applied first to interest and then to principal, with interest thereon from date at the rate of Five per cent, per annum, to be accrued and paid monthly.
