All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the east side of Twin Springs Drive being Lot No. 83 in a subdivision known as Pecan Terrace, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "GG", page 9 and being more particularly described as follows, to-wit:

BEGINNING at an iron pin on the east side of Twin Springs Drive at the joint front corner of Lots Nos. 82 and 83 and running thence with the joint line of said lots N. 64-34 E. 150 feet to an iron pin on the right-of-way line of Air Base Railway Siding; thence with said line S. 25-26 E. 70 feet to an iron pin corner of Lot No. 84; thence with the line of that lot S. 64-34 W. 150 feet to an iron pin on Twin Springs Drive; thence with said Drive N. 25-26 W. 70 feet to the beginning corner.
