To All Whom These Presents May Concern:

I, Helen G. Waters, of Greenville County, South Carolina, SEND GREETING:

Whereas, I, the said Helen G. Waters,

in and by my certain promissory note in writing, of even date with these

Presents, am well and truly indebted to The First National Bank, of Greenville, S. C., as Guardian for Leon Alexander Hendricks,

in the full and just sum of TWENTY TWO HUNDRED and no/100 (\$2200.00) DOLLARS, to be paid as follows: FORTY TWO AND 54/100 (\$42.54) DOLLARS on September 25th, 1954, and to be paid a like sum on the 25th day of each and every succeeding Calendar month thereafter, each of said payments to be applied first to interest and then to the principal balance owing from month to month, until paid in full; with the right, however, to anticipate by the payment of all or any part thereof, at any time before maturity,

with interest thereon from date

at the rate of Six per centum per annum, to be computed and paid monthly, as above,

until paid in full: all interest not paid when due to bear

interest at same rate as principal: and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage: and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

sold and released, and by these Presents do grant, bargain, sell and release unto the said The First National Bank, of Greenville, S. C., as Guardian for Leon Alexander Hendricks, Its Successors and Assigns,

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, on the western side of Means Street, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Means Street, joint front corner with lot of land conveyed by Mary Jane Grimes to T. M. Riley (Vol. 243 at page 204), and running thence (a) N. 73-30 W. 50 feet along line of said Riley lot and along line of other property of Mortgagor, to stake in line of property formerly owned by James Mills: thence N. 27 1/2 E. 50 feet along line of last mentioned property, to stake, corner of other property of Mortgagor; thence (a) S. 77 E. 76 feet along line of other property of Mortgagor, to a point on the western side of Means Street, which point is Fifty (50) feet in a northeasterly direction from point of beginning; thence S. 27 1/2 W. 50 feet along western side of Means Street to the point of beginning.
