SEND GREETING:

Whereas, the said MARSMEN, INC.

a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to HELEN L. TERRY in the full and just sum of THREE THOUSAND AND NO/100 (\$3,000.00) DOLLARS

, to be paid \$50.00 on October 23, 1954 and \$50.00 on the 23rd day of each and every month thereafter until September 23, 1955 when the unpaid balance of principal and interest shall be due and payable. On each monthly payment, interest shall be first paid and the balance applied to principal reduction.

, with interest thereon from date

at the rate of six(6)per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released and by the Presents does grant, bargain, sell and release unto the said Helen L. Terry, her Heirs and Assigns forever;

All those four certain pieces, parcels or tracts of land in Greenville Township, Greenville County, State of South Carolina, being an undivided interest designated as Tract Nos. 275, 276, 277 and 278 on a plat of Augusta Acres, property of Marsmen, Inc., recorded in the R. I. D. 1954 in Greenville County in Plat Book "B", Page 201, containing 23.4 acres and, having, as a whole, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Churchill Circle, joint corner of Tracts Nos. 274 and 275 and running thence with line of Tract No. 274 N. 85-35 E. 592 feet to a stake on the South side of Reedy River; thence with Reedy River in a Northeasterly direction 300 feet, more or less, to a stake, joint corner of Tracts Nos. 275 and 276; thence still with Reedy River 150 feet to a stake; thence S. 50-12 W. 370 feet to an iron pin, joint corner of Tracts Nos. 275 and 279; thence with line of Tract No. 279 S. 8-18 E. 600 feet to an iron pin on the North side of Churchill Circle;
